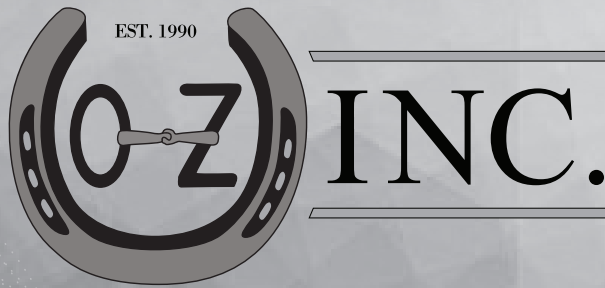

B. # RULES & REGULATIONS

## USEF ENTRY AGREEMENT

By entering a Federation-licensed Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaultor or Longeur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of the United States Equestrian Federation, Inc. (the "Federation") and the local rules of the competition. I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the competition, the Federation, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the Competition may use or assign photographs, videos, audios, cable-casts, broadcasts, internet, film, new media or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. If not currently a USEF Active Competing member or Subscriber and competing only in classes that are exempt from membership requirements, I acknowledge and agree that I will be enrolled at no cost as a USEF Fan and my USEF Fan Account will continue to annually automatically renew unless and until USEF determines in its sole discretion to terminate my Fan account. Additionally, I acknowledge that the benefits of a USEF Fan are subject to change without notice. The construction and application of Federation rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR908.4.

## USEF MEMBERSHIP STATEMENT

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) assistant handlers in Dressage Sport Horse Breeding classes

## EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT FEDERATION RULE BOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH.

Every horse entered herein for competition will be under the control of the Horse Show Management, but the Show Management will in no case be responsible for any loss or damage that may occur, and it shall be a condition of entry that each exhibitor shall hold the horse show and the officials, employees, directors, officers, sponsoring entities of the horse show and the facilities at which the horse show is held blameless for any loss or accident to his horse(s), employee(s), or equipment which may occur from sickness, fire or other cause.

The horse show policies herein stated regarding scratches and refunds will be followed regardless of weather and in place of GR 912 and GR 832.

**ASSUMPTION OF RISK:** By signing the entry blank, the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaultor, or Longeur acknowledges that horseback riding, particularly jumping, is a dangerous activity and involves inherent risks that may cause serious injury and in some cases death because of the unpredictable nature and irrational behavior of horses, regardless of their training and past performance and expressly assumes all such inherent risks whether identified herein, in the entry blank or in the Federation Rules and Regulations. A horse, without warning or any apparent cause, can buck, stumble, fall, rear, bite, kick, run, make unpredictable movements, spook, jump obstacles, step on a person's foot, or push a person-- all of which may cause injury to an observer or rider or to another horse-- a loose horse can run at full gallop in a panic and run into objects or persons or other horses. The Show Ground Facilities are bordered by highways/ roads and thus noise from traffic and other sources occurs that can and will cause a horse to unexpectedly spook or react quickly. The Show Ground Facilities contain roads and driveways that are traversed by cars, golf carts, tractors, trailers, and heavy equipment, all of which may spook a horse. The above warnings and risks are meant as an example of some of the risks that are inherent and may be encountered but it is agreed this is not an exhaustive list and there are numerous additional conditions and/or events that may result in injuries while participating in the Competition and/or being present on the Show Ground Facilities. **Reminder: all USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the, U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. ## ENTRY PROCEDURE

CLOSING DATE OF ENTRIES: ENTRY FORMS MUST BE RECEIVED, VIA SHOWGROUNDSLIVE.COM, BY THE DATE LISTED ON THE ENTRY BLANK FOR EACH RESPECTIVE SHOW.

### Entry Blank Requirements:

1. All horses on the grounds must be registered on an entry blank including horses not entered in classes. One entry blank per horse.
2. Entry forms must be completed with owner, riders, trainers and payee information including association membership numbers on showgroundslive.com.
3. Date of Birth of all minor exhibitors.
4. Signatures of owner, riders, trainer and parent or guardian of minor exhibitors. Parents or guardians of minor exhibitors shall hold the Horse Show, Team NW Equestrian Sports, LLC, and staff harmless for injury to such minor(s).
5. USEF name of horse, correct description of horse and USHJA ID number.
6. Classes may only be entered or declared by using a class number. Classes must be entered on showgroundslive.com.
7. For all horses, the Horse Deposit fee and Stall fee must be paid by a credit card (Visa or Mastercard only) on showgroundslive.com. Each transaction will be charged a 4% convenience fee. Rider/Trainer/Owner agrees that Horse Show Management is authorized to charge the credit card pursuant to the information contained in the entry blank at the conclusion of the Competition.
8. If entry blanks are received prior to the closing date of entries AND are properly filled out, the Horse Deposit fee will be credited to the entries due. LATE

AND/OR IMPROPER ENTRIES WILL FORFEIT THE HORSE DEPOSIT FEE.

9. DO NOT make entries from the time schedule. Consult the Class Index. Time schedules are subject to change after the close of entries.
10. Non Showing horses must be declared on the entry blank and pay the Non Showing horse fee. Leaving the class area "blank" constitutes an entry and will be charged a scratch fee, if the horse does not show.
11. Post Entries will be accepted after the closing date of entries and during the show at regular fees plus Post Entry Fee (See Fee Schedule).
12. Coach. For purposes of these rules, a coach is defined as any adult or adults who receives remuneration for having or sharing the responsibility for instructing, teaching, schooling, or advising a rider, driver, handler or vaulter in equestrian skills.
13. All fees must be paid in U.S. funds via Visa or Mastercard for the Horse Deposit and Stall on [showgroundslive.com](http://showgroundslive.com). The balance on accounts may be paid by credit card or check at the completion of the show. All credit card charges will be charged a 4% convenience fee.

## Office Check-in, Adds/Scratches, Eligibility and Check-out

1. The Show Office will be open schooling day from 8:30 a.m. to 4:00 p.m. and on show days from half an hour prior to start of classes until 4pm.
2. A blank check or credit card is required at the time of check in before numbers will be issued.
3. Checks returned by the bank for any reason will incur a Returned Check Fee (See Fee Schedule), and will be re-deposited. In the event a check is returned by the bank after the completion of the show, it will be handled in accordance with USEF GR913.
4. Exhibitors are encouraged to close out their own accounts. Management will close Exhibitor Accounts that have not been settled at the conclusion of each show. Billing questions or refunds will not be considered.
5. Any exhibitor who does not compete in a class in which he/she is officially entered, and has not scratched the class in the Horse Show Office, will be billed for the class.
6. Horses showing in a class that they are not entered in will be billed double the entry fee for the class.
7. Exhibitors are responsible for their own errors and omissions and for knowing the cross entry restrictions for the divisions they are entered in. In the event of a violation of a cross entry restriction, the exhibitor will forfeit the entry fee, class placing and prize money award.
8. To be eligible for a stake class, the horse must have been entered, shown and judged in at least one over fences class in that section.
9. Measurement cards. Those competing in small junior hunters, hunter ponies, jumper ponies and small hunters must possess a measurement card. If not, horse or pony must be measured by show steward before competing.
10. All class entries must be declared by 4:00 PM.
11. Late declarations will pay post entry penalties and may be required to work first in the order. Horses scratched the day of the class will remain responsible for half of the class fees in Special Classes. Classes entered on the entry blank constitute a declaration.
12. Equine Vaccinations. All horses whether competing or not are required to present the USEF Vaccination Record: Equine Influenza and Equine Herpes form found at [www.usef.org/forms-pubs](http://www.usef.org/forms-pubs)

## Refunds & Scratches:

1. Before the closing date of entries full refunds will be given, minus credit card fee.
2. After the closing date of entries, the Horse Deposit, and stall fee are not refundable.
3. After the show starts, with the official show vet's certificate only, entry refunds will be given less a Scratch Fee, stall fee (see Fee Schedule) and fees for classes already held prior to notification at the horse show office, whether exhibited in or not. If the vet scratch involves a division fee for sections required by USEF to be held as a division, no refund will be issued for such division.
4. With a vet certificate, a new horse may be substituted for a scratched horse and be charged a Substitution Fee (see Fee Schedule) for the substitution.
5. Full credit will be given for classes scratched in the Horse Show Office PRIOR TO THE START of the class, EXCEPT for Special Classes.
6. In the event that a horse is vetted out, there will be no refund of stall or tack room fees.

## Fee Schedule:

1. For every horse participating in any competition licensed by the Federation, a Federation fee will be collected (a portion of the fee shall be an Equine Drugs and Medication fee to provide for research, inspection, and enforcement of rules regarding use of medications and drugs; see GR407.1, .2 and .3). Exception: Horses entered in classes exempted from the Equine Drugs and Medication fee are also exempt from the balance of the Federation fee. A \$10 USHJA fee will be charged for each horse in performance and/or equitation classes at National and Premiere shows, and a \$5 USHJA fee per horse at Regional I and II shows. To be remitted to USHJA.
2. Post Entry Fee. Regular fees will be charged for all post entries plus a \$50/ horse Post Entry Fee.
3. Returned Check Fee. A check returned or credit card charged back for any reason will incur a 10% of face value of the check or charge back or \$50, whichever is greater.
4. Scratch Fee. Horses scratched from the show will be charged a \$50 Scratch Fee.
5. Substitution Fee. Horses substituting for a scratched horse will be charged a \$25 substitution fee.
6. Haul-In Showing Fee: Horses not purchasing stalls will be charged a haul-in fee of \$50/day/horse.
7. Haul-In Schooling Fee: Horses hauling in Tuesday to school will be charged \$150/horse.
8. Clean-Up Fee: Horses bringing in their own shavings will pay a \$50/stall/week clean-up fee.
9. Non Showing Horse Fee: Non showing horses will pay a \$150 non-showing horse fee.
10. Convenience Fee: all accounts closed with a credit card will pay a convenience fee of 4%.
11. High Jumper Nomination: Horses entered in any 1.20m or higher jumper class must pay a \$150 High Jumper Nominating Fee.
12. Mandatory Office/Grounds fee of \$150 will be charged to all horses.
13. Mandatory Manure Removal fee of \$60 will be charged to all horses except those hauling in.
14. RV Parking- RV Hookups, 30-amp power and water provided for \$400 per week, spots will be assigned.
15. Dry Camping per week \$150.
16. Stalls per week 10x10 \$325, 12x12 \$450. Reservations for 12x12 stalls will be on a first come first serve basis, and must be reserved with Sara via email [teamnwshows@gmail.com](mailto:teamnwshows@gmail.com).
17. Mandatory Photography Fee \$55 per horse, each horse will receive all low res digital images captured during the week. High res images may be purchased at additional cost.

## Awards and Prize Money.

1. All regular class winners will receive a Prize Ticket or trophy and ribbons thru 8th place, in addition to any prize money.
2. HUNTER/EQUITATION Show Champion and Reserve: Hunter champion and reserve will be awarded to 2 of the 4 horses scoring the most points over fences. In addition, only these will receive full points for ribbons won under saddle and half points for ribbons won in the model. Points will be awarded: 10, 6, 4, 2, 1, 1/2.
3. JUMPER Show champion and Reserve: Jumper champion and reserve based on points awarded 10, 6, 4, 2, 1, 1/2. Exception: Junior/amateur jumper will be based on money won.
4. Prize money will be deducted from each account at the show, unless otherwise instructed by the Payee. If requested a check will be mailed within 30 days after the close of the show. Prize money checks will be void and not reissued after 90 days. NO PRIZE MONEY WILL BE DEDUCTED/PAID/MAILED UNLESS THE OWNER'S OR PAYEE'S SOCIAL SECURITY NUMBER/TAX ID NUMBER IS LISTED ON ENTRY FORM. Prize money in all classes, excluding Special Classes and Jumper Classics, will be divided 30%, 25%, 20%, 15%, 10% or as per USHJA Rules. Prize money for Special Classes will be distributed as follows unless otherwise stated. Internal Revenue Service requires 30% of prize money won by foreign exhibitors to be withheld. Foreign exhibitors should apply for a US Social Security number and are required to complete a W-8 Certificate of Foreign Status Form.

## GENERAL INFORMATION

1. Schooling - Ticketed schooling rounds will be available on the day prior to the first day of the show, heights and times will be posted at the show office. Horses hauling in for schooling will pay a fee and must sign a release waiver. Please see Fee Schedule for pricing.
2. Poling - Poling is prohibited.
3. Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.
4. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.
5. Sharps. Sharps containers will be placed in convenient places in the stabling area. Competition management may fine any individuals including trainers, owners, exhibitors, or their agents up to \$100 for improper disposal of needles or other sharp disposable instruments. (GR 1210.4)
6. Arenas, warm-up areas. Wilsonville – all arenas have all weather fiber and sand footing. Jumper arena is 170' x 350'; hunter arenas 150' x 300'; hunter derby arena 300'x300'; lunging arena 50,000 square feet; schooling/exercise areas 91,000 square feet.
7. Stabling. Temporary 10 x 10 and 12 x 12 box stalls with full doors and natural/grass floors are provided. Stalls are available from 1:00 p.m. two days before the start of the show through 9 p.m. Sunday. Stalls and tack rooms for the duration of the show are priced for each show on the respective Entry Blank. Bag shavings are available for purchase.
8. RV hookups. 30 amp RV hookups for the duration of the show are available on a limited basis. See respective Entry Blank for pricing.
9. Clean-up Fee: Exhibitors supplying their own shavings at the show will pay a Clean-Up fee (see fee schedule).
10. Protective headgear. It is compulsory for all persons at Federation licensed hunter, jumper or hunter/ jumper competitions when mounted anywhere on the competition grounds, to wear properly fastened protective headgear which meets or exceeds ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. It must be properly fitted with harness secured. Exception: In Hunter or Jumper classes,

adults may be allowed to remove their headgear while accepting prizes and during the playing of the National Anthem only; they must refasten their headgear prior to the lap of honor. A Show Committee must bar riders without protective headgear from entering the ring for classes in which protective headgear is required and may bar any entry or person from entering the ring if not suitably presented to appear before an audience.

11. Curfew and quiet times must be observed between 9pm and 5am (as required by GR1215.3 #033-22)

12. Attire. Proper attire is required in all rings during competition.

13. Protests. Any rider, driver, handler, vaulter, longeur, exhibitor, owner, agent, trainer or parent of a junior exhibitor, or any life, senior or junior member present at the competition may file a protest with the show committee of a licensed competition or with the Federation hearing committee alleging violation of any Federation rule(s). The protest must be a) in writing; b) signed by the protester; c) addressed to show committee of the competition at which the alleged violation occurred, or to the hearing committee; d) accompanied by a deposit of \$200 if made by a Federation member or parent of a junior exhibitor member, or \$300 if made by a nonmember; e) received by the steward, member of the show committee, competition manager or secretary within 48 hours of the alleged violation. If made directly to the hearing committee, the protest must be received at the Federation office by the 10th business day following the last recognized day of the competition, or by the 10th business day following the date on which the alleged violation occurred if it occurred other than at a licensed competition.

14. Jumper orders. The order of go will be drawn and for jumper classes with a jump-off, horses will go in the original drawn order.

15. Time Allowed: The time allowed will be based on a speed of 360 yards per minute for pony jumpers, and 382 yards per minute for all the other sections unless otherwise noted, and may be adjusted accordingly.

16. Martingales: In jumper classes offered at 1.30m and below, there are no martingale restrictions when used in a conventional manner. JP111.1a.

17. Ties: Ties involving first place in jumper classes will be jumped off. Ties not involving first place will be decided upon by time unless otherwise stated.

18. Two Level Jumper Classes: Jumper classes may be combined and run as two level classes if lack of entries warrant. See JP 122.1c.

19. Zone Specifications: This competition is in USHJA Zone 9. Please see Zone 9 Specifications (MT, WY, ID, OR, WA) at [www.ushja.org](http://www.ushja.org).

20. When Management deems necessary dotted lines may be used on any hunter or equitation courses.

21. For the purposes of eligibility and cross entry corresponding heights are below:

## **SPECIAL CLASS CONDITIONS:**

Horses scratching from Special Classes are subject to the special class Scratch Fee. Scratching special classes AFTER 4 PM the day before the class results in forfeiture of half of the entry fees. Formal attire is required in all special classes. Special classes will not count toward show champion and reserve awards. Horses must have entered and shown in at least one other class at the horse show to be eligible for Special Classes.

### **Special Hunter Classes:**

**USHJA National Hunter Derby:** This class will consist of two courses, a traditional hunter classic course and a handy hunter course. The top 12 horses from the First Round will be invited back for the Handy Round. A minimum of 10 horses MUST be entered in each derby for the respective class to run. Fences 3'0" with options to 3'5". For complete specs please visit [www.usnja.org/competition/hunter/national-hunter-derby](http://www.usnja.org/competition/hunter/national-hunter-derby).

**USHJA Green Hunter Incentive Stake:** This class will run concurrently with the last class of the respective division, the entry must be entered in the USHJA Green Hunter Incentive Stake class separately from the Green Hunter corresponding height section in order to be eligible for the additional prize money. For complete specs please visit [www.usnja.org/competition/hunter/green-hunter-incentive-program](http://www.usnja.org/competition/hunter/green-hunter-incentive-program).

**Cypress Events Local Hunt & Go Derby:** This class will consist of two (2) phases, one (1) Classic Hunter and one (1) Handy Hunter. The phases will be jumped consecutively. Each phase will have 5-7 fences (2'6") and two (2) high options (2'9"). Open to Juniors and Amateurs. No cross entry into any hunter class with fences above 2'9" with the exception of the Large Pony Hunters. No cross entry into any jumper class with fences above 0.95m. Fences 2'6" with options to 2'9". A minimum of 10 horses MUST be entered in each derby for the respective class to run. Rider may not cross enter with any over fences class e

**Team NW International Hunter Derby:** The Classic round and the Handy round will have the majority of the course set at 3'6" and may have the balance of the jumps not to exceed 3'9" with the exception of four high option jumps which will not exceed 4'0".

Handy round must have a minimum of eight (8) fences.

The spread of a fence cannot exceed the height of the fence. (Applies to both Classic and Handy rounds.)

The course should be equally balanced, when possible, between verticals and oxers. (Applies to both Classic and Handy rounds as well as option fences.) The course will include derby type jumps.

**USHJA Zone 9 Handy Hunter Challenge:** This class will be held as a one round Handy Hunter class. A minimum of 6 entries is required for the class to run and of those, a minimum of 3 rounds must be scored for double points towards USHJA Zone Horse of the Year standings. Children's and Adult riders entered in the Handy Hunter Challenge may not cross enter any class where fences exceed 3'9". ### **Special Jumper Classes:**

In the event that any of the Jumper Classics do not reach a minimum of 10 entrants, management reserves the right to do any of the following:

- Combine classics to reach minimum number of 10 entrants
- Run classes at two different heights. Height difference to be a maximum of 10 cm.
- Cancel the class
- Lower height and change prize money
- Raise the prize money if entrants warrant.
- Take classes restricted to juniors and amateurs and make them open classes
